6.3. PARENT LETTER TO COMPLY WITH EDUCATION CODE 51228.1

Assembly Bill (AB) 1012, which will commence at the beginning of the 2016-17 school year, adds new sections 51228.1, 51228.2 and 51228.3 to the Education Code (EC), concerning the conditions under which a public school pupil in grades 9 to 12 can be assigned to a “course period without educational content” for longer than one week This would include students who serve as Teacher Assistants. While it is the practice of NBECHS to sparingly assign students to TA periods, it does happen. This letter is necessary to bring the school into compliance with Ed Code 51228.1 through 51228.3.
